The work broadly may involve providing quality training to selected candidates at the Livelihood College in Narayanpur on the basis of MES syllabus prescribed by CSSDA (www.cssda.in). The agencies may also have to provide necessary reading material for the respective trainings. The medium of instructions for the training and the reading material shall be in Hindi. The training shall be provided based on a schedule that will be provided by the Jila Pariyojana Livelihood College, Narayanpur. The training shall involve classroom as well as practical teaching with all the modern methods of training.

The NGOs/GOs/Academic institutions/Training agencies/firms fulfilling the following criteria may apply:

- The intending NGOs/GOs/Academic institutions/Training agencies/firms should have adequate exposure and expertise in training and capacity building of rural communities on the respective subjects.
- The intending NGOs/GOs/Academic institutions/Training agencies/firms should have link with the marketing agencies as they have to ensure marketing of products after training. Proofs regarding links with marketing or earlier marketing of handicraft products.
- The intending NGOs/GOs/Academic institutions/Training agencies/firms should be equipped in providing training through all the novel and modern methods of training (including audio-visual).

The Firms/Agencies should meet the following basic criteria:

- The NGOs/GOs/Academic institutions/Training agencies/firms should be a registered entity. (Please attach document for proof)
- The NGOs/GOs/Academic institutions/Training agencies/firms should have completed at least five trainings of similar nature. (Please attach document for proof)

- The NGOs/GOs/Academic institutions/Training agencies/firms should have minimum experience of 3 years in the field. (Please attach document for proof)
- The agency need to provide following during the period of contract
 1. Qualified and experienced Trainer
 2. Tools and equipments for all candidates
 3. Raw material for production during training
 4. Marketing of products from training and market linkage
 5. Production and design support to the organization of craftsmen

The NGOs/GOs/Academic institutions/Training agencies/firms should intimate their interest by submitting the detailed project proposal for per hour cost per student, along with proof for past experience of the organization, details of trainers, detailed implementation plan, etc. through registered/speed post or by hand which should reach the Office, Jila Pariyojana Livelihood College, Room No. 24, Zila Panchayat, Narayanpur by 4:00 PM hrs on 24-04-17..... The Envelop should clearly mention "Project Proposal for providing training in various courses (Write Course Name) at Jila Pariyojana Livelihood College Narayanpur, Chhattisgarh" on the top. The Project proposal will be opened on the same day at 5:00 PM hrs.
